The Center is open from 7:30 a.m. to 6 p.m. The participant family caregivers are given a much needed respite, in addition to education on the disease process, and support in the form of family socials, monthly support groups, and care conferences. Amazing Place moved into its new state of the art facility in late June 2010.
